Section 215.559, Florida Statutes, established the Hurricane Loss Mitigation Program. A portion of the funding for this program is to be used to inspect and improve tie downs for mobile and manufactured homes. The intent and purpose of the RFP is to secure a contract with a qualified vendor to provide windstorm safety enhancements (tie downs) to manufactured/mobile homes and for mobile home parks and manufactured home communities around the state. During fiscal year 2017-2018, it is anticipated that approximately 3,000 manufactured/mobile homes will be eligible statewide.
