These criteria are contained in Section 4.1 State Requirements for Educational Facilities, Rule 6A-2.0010, Florida Administrative Code and are embodied in this application without modification as required.

The Board elected the option, as provided in the above cited Rule, to pre-qualify General Contractors on an annual basis to competitively bid projects between \$1 million and \$5 million dollars. Therefore, this Pre-qualification application (RFQ) will cover the period of January 1, 2019 through December 31, 2020.
