SUBJECT: Academic Programs and Course Changes

Item Description

This item presents proposed changes in curriculum for 2018-2019.

Overview and Background

The Academic Planning Committee Curriculum members review and make recommendations for Board approval for new program and courses. Due to changes by the State Board of Education as well as the revision of programs to meet workforce demands, there are several changes that are being proposed.

The college is proposing a change to the Early Childhood Development, Education and Management A.S. degree program. The change includes adding a course that will allow students to earn an additional industry certification. The Infant/Toddler Specialization will allow students to be more marketable and increase their earning potential. The college is also proposing a change to the Network Systems Technology A.S. degree program. Employers are requesting for students to have a general purpose programming language such as Python. Faculty are proposing to add a new course that will teach students Python in order to meet the workforce needs.

Past Actions by the Board

The Board approves the curriculum changes each year. The changes are for 2018-2019.

PROGRAM CHANGES

Early Childhood Development, Education and Management, A.S. (60 credit hours) – Based on information provided by the curriculum advisory group, which consists of employers of childcare centers as well as stakeholders from the Office of Early Learning and the Department of Children and Family Services, program revisions are necessary in order to align TCC's program with a new career pathway from the Office of Early Learning. Employers are asking TCC to add a course to the current program that will allow students to earn additional industry certifications for employment. This additional course will allow students to earn the Infant/Toddler Specialization, which will allow students to be more marketable and increase their earning potential. In order to accommodate adding the course to the program, we must eliminate a course in order to remain at the state required 60 credit hour program length. The course is being eliminated from this program is no longer a state mandated requirement.

Add this course: EEC2500 Infant and Toddler Development (3)

Delete this course: EDF2085 Introduction to Diversity for Educators (3)

Network Systems Technology, A.S. (60 credit hours) – The curriculum advisory board, which consists of network systems employers, have asked TCC to broaden access to some of the popular beginning programming languages. Employers are looking for students to have a general-purpose programming language instead of languages built for specific fields. TCC is proposing to add Python, which is a general-purpose language. Python is used for many different things such as writing scripts and developing networking tools as well as building scripts for digital media. This language would serve students in several programs including programming, networking, cybersecurity, web development and digital media making them more marketable for employment. This course will be added to the elective area of the program to allow students to choose the track that is suitable to their employment interests.

Add this course: COP1000 Programming Concepts (3)

EDF2500	Infant and Toddler Development (3)	This new course will be added to the Early Childhood Development A.S. degree to fulfill the request for the Infant/Toddler Specialization industry certification.
MAT0027	Foundations of College Mathematics II for Liberal Arts (4)	This new course will provide a new pathway for students in developmental math who are not interested in going into a STEM discipline. This course will provide the non-algebraic foundational math skills necessary to be successful in the majors that are not related to Business and STEM.
SOP2780	Psychology of the African American Experience (3)	This is a new courses that will be added to the A.A. degree as an elective. This course will provide additional preparation for students majoring in Psychology as well as cultural awareness of the African American experience.

GRA2105C	Graphic Based Design II	Change the pre-requisite	Current pre-requisite is: GRA2103C (Computer Based Design I) and GRA2121 (Publication Design)	Proposed pre-requisite is: GRA111C (Graphic Design), GRA1206C (Typography), PGY2801C (Photoshop)	This change will allow students to take this capstone course in either the fall or spring semester instead of waiting until they complete GRA2103C, which is also a capstone course. Waiting prolongs graduation and the content is not dependent on each class.
